The traceability standard is part of SEIA's broader effort to professionalize and standardize best practices across the U.S. solar industry.

In summary, while the Solar Stewardship Initiative's Supply Chain Traceability Standard claims to represent a step towards greater transparency in the solar value chain, it falls short in addressing critical issues such as forced labour, human rights violations, and the integrity of its certification process.

<div class="df_qntext">What is a solar tracing standard?

This new Standard provides a robust framework for tracing silicon (or other semiconducting materials) throughout the solar supply chain. Independent auditors will use the Standard to assess the traceability of key materials used in solar production sites. Successful assessments will lead to a certification award.

<div class="df_qntext">What is the SSI supply chain traceability standard?

Alexia Ruvoletto, Head of the SSI Secretariat, commented: "The SSI Supply Chain Traceability Standard sets a new bar for end-to-end supply chain accountability in the solar sector. By establishing a clear, verifiable chain of custody for materials, it lays the groundwork for a more sustainable and ethical solar industry."

The traceability standard claims it will "allow stakeholders to be confident that the silicon used in the solar modules was produced responsibly," however, it fails to sufficiently address how it can ensure that the mixing of certified and non-certified silicon will not occur at a site when polysilicon blending is common in the industry.

<div class="df_qntext">What is solar supply chain transparency?
